- 1040 **Arrive Hongqiao Airport and depart for hotel.**  
Met by Consul General Henry Levine, Garrison Commissar Zhang Lizhi and wife, and possibly Municipal FAO Director Zhou Mingwei

- 1100 **Arrive Portman Ritz-Carlton Hotel and check-in to room.**  
Met by US Consulate Administrative Chief Robert Frazier.  
(total time: 60 minutes)
- 1205 **Depart Portman Hotel for Jinjiang Hotel.**  
(travel time: 10 minutes)
- 1215 **Meeting and lunch with Mayor Xu Kuangdi.**  
Met at Jinjiang Hotel front door by Zhou Mingwei and led to Small Auditorium.  
Gift exchange.

- 1350 **Depart Jinjiang Hotel for Pudong Central Park. SecDef plus 12. (Mrs. Cohen (b)(6) [redacted] depart separately.)** b3

- 1350 Mrs. Cohen (b)(6) [redacted] are met at Jinjiang Hotel by site officer Christy Ho. Choice of activity includes:  
--car tour of scenic Bund led by local Shanghai historian, Tess Johnston;  
--tour of Shanghai museum led by English audio tapes.  
--return to Hotel for rest.

- 1545 **Arrive Shanghai Stock Exchange.**  
Met at front door by Stock Exchange Managing Director Tu Guangshao and Executive Vice President James Liu. SecDef is led to holding room for brief meeting with Tu and Liu.  
*(total time: 10 minutes)*
- 1600 **Deliver speech on floor of the Shanghai Stock Exchange.**  
Introduced by President Tu, then Ambassador Prueher.  
Speech followed by audience Q&A session.  
Gift Exchange.  
170 (approx) audience members invited, consisting of Shanghai government and Garrison hosts, American and Chinese business community, Chinese research scholars, and SecDef delegation.  
*(total time: 30 minutes)*
- 1630 **Hold Press Conference at Shanghai Stock Exchange.**  
Led to venue in second floor conference room.  
25 Chinese, American and third country reporters participate.  
*(total time: 30 minutes)*
- 1700 **Depart Stock Exchange for Portman Ritz-Carlton.**  
*(travel time: 30 minutes)*
- 1730 **Arrive at Hotel for down time before dinner .**

*(total time: 90 minutes)*

- 1900 **Host small dinner for American and Chinese business community in the Portman Ritz-Carlton, 4th Floor Marble Hall 2.**  
**30 American and Chinese participants**  
*(total time: 120 minutes)*
- 2100 **Dinner ends. RON at Portman- Ritz Carlton Hotel.**
