 - b. Formal reports of sexual harassment by Service members: FY 06: 49; FY 07: 102; FY 08: 84; FY 09: 84; FY 10: Not available until released to Congress 15 Mar 11. Army only tracks formal reports of sexual harassment, not informal reports.
