
Dear Mr. DiRita:




leader who inspires others to follow. General Lynch possesses all of the talents necessary to lead the National Guard into a future that will be filled with profound changes and new challenges.




Dear Mr. Secretary:

I was pleased to have successfully sponsored Section 8151 of the FY 2002 Defense Appropriations Act giving you the ability to authorize the use of Title 38 pay and benefits levels for Department of Defense nurses and other specified medical occupations.

This new compensation authority was meant to address the continuing problem the Department has experienced in attracting and retaining fully qualified civilian nurses and other key medical personnel. Until now, your military medical commands have been required to operate under the out-dated pay structures specified by Title 5, which has put them at a significant competitive disadvantage. Shifting to Title 38 authorities should result in saving the taxpayers millions of dollars by greatly reducing the need to fill persistent personnel shortages with very expensive contract nurses and will also alleviate high nurse turnover rates.

I would appreciate receiving a report from your staff on the status of implementing Section 8151. I would also request a breakdown comparing old and new pay structures and other key personnel policy changes that will result from this change in law, the number of personnel that are expected to be employed under the new Title 38 authority by service and by occupation for each of the next three fiscal years, and the expected cost savings by service from reduced dependence on contract specialists for this same time period.

I am writing on behalf of Donna and William Strickler, from W.H. Strickler Trucking Company.


They applied to the Department of Defense several months ago and advised they were interested in hauling in one of DODs "Guaranteed Traffic Freight lanes" only.

*Dear Secretary Rumsfeld,*


*I have just read an article in the New York Times describing the Pentagon's plan to spend hundreds of millions of dollars on complex surveillance and counter insurgent devices. While some of this equipment may need to be fielded as soon as possible, I am concerned that not enough attention is being paid to what I call the X-Factor, the spirit of the enemy. Every time an American service member kills an Iraqi, the ordinary Iraqis see us as the enemy and we further enflame the extremists. When we are seen as the enemy, we are not winning the hearts and minds of the Iraqi people. Winning the hearts and minds of the Iraqi people is critical and this cannot be accomplished without the proper training of our troops.*

*When an RPG is fired at our troops and the perpetrator disappears into the crowd, we must rely on the Iraqi people to identify the perpetrator or to provide intelligence that will lead to his/her identification. Our efforts should therefore be primarily concentrated on developing key relationships with the Iraqi people instead of counting on forensic data, computer programs and sophisticated radar to help find homemade bombs and guerilla activity.*

*In my most recent visits to Walter Reed, the troops expressed concern over the lack of training in urban warfare. Many said that they were operating outside of their MOS with little or no training in their newly assigned task. For instance, an infantryman was working primarily military police duties. Another soldier was assigned the task of giving out paychecks to a crowd who was becoming increasingly unruly. He was uncomfortable with the situation and commented, "I just had to show them who was boss."*

*I understand the Army has shortages in critical MOSs in Iraq, and as many as 6300 may be working outside of his/her appropriate MOS. I believe proper training and ensuring our troops are working within their MOS is a necessary step toward winning the hearts and minds of the Iraqi people. We need them on our side.*
