SUBJECT: Cost Principles Changes Required by Public Law 99-145

This Departmental contains changes to the Federal Acquisition Regulation (FAR) to implement the FY 86 DoD Authorization Act, Pub. L. 99-145 as it pertains to FAR Part 31, Cost Principles.

Pending publication of a forthcoming FAC (#84-15), the DAR Council at its meeting of 28 March 1986 authorized expedited distribution of the attached changes to the FAR, as approved by the DAR Council, the Civilian Agency Acquisition Council, and principals in DoD, GSA and NASA, in order to comply with the statutory effective date.

The attached changes (TABS B through M) are based upon the requirements of Title IX, Section 911, and Title XV, Section 1534, of Pub. L. 99-145.

The following FAR paragraphs are amended:

31.109(h)(8) and (h)(16), Advance Agreements (DAR Cases 84-144 and 84-217).

31.205-1, Public relations and advertising costs (CAR Case 84-144).

31.205-6(b) and (m), Compensation for personal services (DAR Cases 83-62 and 85-200).

31.205-8, Contributions or donations (DAR Case 85-194).

31.205-13, Employee morale, health, welfare, food service, and dormitory costs and credits (DAR Case 85-101).

31.205-14, Entertainment costs (DAR Case 85-195).

31.205-15, Fines and penalties (DAR Case 85-194).

31.205-22, Lobbying costs (DAR Case 85-197).

31.205-33, Professional and consultant service costs (DAR Case 85-100).

31.205-38, Selling costs (DAR Case 85-199).

31.205-46(d) and (f), Travel costs (DAR Cases 84-217 and 85-200).


31.205-47, Defense of fraud proceedings (DAR Case 85-194).

31.205-50, Executive lobbying costs (DAR Case 85-197).

31.205-51, Costs of alcoholic beverages (DAR Case 85-196).

These changes are effective for solicitations issued after 7 April 1986.
