[9] Ms Matos and [10] from the day of my arrival here have displayed uncalled for deception, disseat and out-right insubordination toward me and anyone else they believe is on to their system of gaming management for their personal benefit. Let me begin with the timely departure of Ms. Matos (GS-11 Security Specialist), she was at long last given a validated letter of reprimand for failure to follow supervisory instructions. This was basically upheld in resolution of her grievance; she then resigned

It now turns out, she is back at DoD OUSDI, as a contractor from CSC (Matos, Priscilla CTR OSD OUSDI, Chrystal Square 2, Suite 502-B) there is no record of her reprimand and no reference to long months of sub-standard performance in SAP/security admin functions, her unprofessional aloof attitude toward OMC management and her actions to initiate EEOs, congressionals and other complaints against personnel from OMC and OUSDI, involving a myriad of concocted tails.
