

1. Any comments on the draft CBW legislation discussed at the meeting should have been received by **COB January 9**. The draft legislation will then be submitted to OMB for interagency legislation clearance, with a view to obtaining an agreed Administration bill the week of January 14. (S)
2. Comments on the draft interim rule on the imposition of foreign policy controls circulated by the Department of Commerce should be submitted by all agencies to the Department of Commerce by **COB January 16**. (S)
3. The Department of Commerce should have reported to the Chairman of the PCC on the work of the legal committee considering the legal framework for imposing sanctions against U.S. citizens by **COB January 10**. (S)

In addition, a sub-PCC met immediately following the conclusion of the PCC to review implementation of the taskings noted in the minutes of the meeting of the Non-Proliferation PCC of December 14, 1990, and agreed that Item 3 should have been completed by **January 11**; Items 4, 5, 6, 7, and 9 would be completed by **January 15**; and Item 8 would be completed by **January 20**.
