-- On the contracts for the democracy and governance group, I simply passed to ORHA's contracting officer requests from Deputy Secretary Wolfowitz to hire the individuals identified. (b)(6) (b)(7)(C) has been managing this project and is now serving as the point of contact for all involved.

-- On contracts for (b)(6) (b)(7)(C) I merely passed along to ORHA's contracting officer requests from Jay Garner to bring these gentlemen on board through appropriate contracting means.

-- On the contract for (b)(6) (b)(7)(C) I merely passed along to ORHA's contracting officer a request from Mike Mobbs to renew (b)(6) (b) contract. Mobbs had brought (b)(6) in to his Energy Infrastructure Protection Group before ORHA came into existence.
