

SIDE LETTER BETWEEN
THE COALITION PROVISIONAL AUTHORITY IN IRAQ
AND
THE GOVERNMENT OF THE HASHEMITE KINGDOM OF JORDAN
CONCERNING REIMBURSEMENT FOR
LOGISTICAL SUPPORT
CONCERNING ACCESS TO AND USE OF FACILITIES IN JORDAN
FOR INTERNATIONAL POLICE TRAINING

This Side Letter ("Letter") is entered into between the Coalition Provisional Authority, which is exercising temporary governmental authority in Iraq pursuant to the laws and usages of war, and consistent with United Nations Security Council resolutions, including Resolution 1483, (hereinafter "the CPA") and the Government of the Hashemite Kingdom of Jordan (hereinafter, "Jordan"), represented by the Public Security Directorate (hereinafter referred to as "the PSD").

WHEREAS, the CPA and the PSD (hereinafter "the Parties") have entered into a contractual agreement concerning access to and use of facilities in Jordan for Iraqi police training (hereinafter "the Basic Agreement") and,

WHEREAS, Article IV of the Basic Agreement provides that the CPA and the PSD will negotiate terms and conditions for the PSD to provide logistics support for the purpose of supporting Iraqi police training under the terms of the Basic Agreement.

NOW THEREFORE, in order to more fully implement the foregoing article of the Basic Agreement, the Parties agree as follows:

ARTICLE I

AMOUNT OF LOGISTICAL SUPPORT

The Parties agree that the CPA, in accordance with Article IV of the Basic Agreement, will enter into a contract or similar instrument with the PSD containing a mutually agreed scope of work and mutually agreed terms and conditions to provide logistical and base operations support as described in Article IV. The Parties agree that the cost for the support described above will be in an amount not to exceed Eighty-Nine Million Dollars (\$89,000,000) for the first year, except as mutually agreed upon between the Parties.

ARTICLE II


OBLIGATION OF FUNDS

CONCERNING PARTIAL REIMBURSEMENT FOR
SECURITY ARRANGEMENTS
CONCERNING ACCESS TO AND USE OF FACILITIES IN JORDAN
FOR INTERNATIONAL POLICE TRAINING

This Side Letter ("Letter") is entered into between the Coalition Provisional Authority, which is exercising temporary governmental authority in Iraq pursuant to the laws and usages of war, and consistent with United Nations Security Council resolutions, including Resolution 1483, (hereinafter "the CPA") and the Government of the Hashemite Kingdom of Jordan (hereinafter, "Jordan"), represented by the Public Security Directorate (hereinafter referred to as "the PSD").

WHEREAS, the CPA and the PSD (hereinafter "the Parties") have entered into a contractual agreement concerning access to and use of facilities in Jordan for Iraqi police training (hereinafter "the Basic Agreement") and,

WHEREAS, Article III (G) of the Basic Agreement provides that the CPA and the PSD will negotiate amounts to be reimbursed for a portion of the costs incurred by the PSD in providing security under the terms of the Basic Agreement.

NOW THEREFORE, in order to more fully implement the foregoing article of the Basic Agreement, the Parties agree as follows:

ARTICLE I

AMOUNT OF REIMBURSEMENT

The Parties agree that the CPA, in accordance with Article III (G) of the Basic Agreement, will reimburse the PSD in an amount not to exceed Five Million Dollars (\$5,000,000) per year for a portion of the costs incurred by the PSD in providing security for the facilities described in the Basic Agreement. The initial one-year period will commence on the effective date of the Basic Agreement, and continue on a year-to-year basis for the duration of the Basic Agreement, unless the parties agree otherwise.

ARTICLE II


OBLIGATION OF FUNDS

The Parties agree that the obligation by the CPA to pay the PSD under the provisions of this Letter is specifically subject to the availability of proper funds.


